Subject: Desk Review Meetings to assess the implementation of RKVY-RAFTAAR during 2018-19 -reg.

The Desk Review Meetings (State wise) were convened at Krishi Bhawan, New Delhi from **29th October, 2018 to 02th November, 2018** under the Chairmanship of Ms. Chhavi Jha, Joint Secretary (RKVY).

- 2.** The following agenda was the basic purpose of the meeting:
- (i) Review of physical/financial progress of implementation of projects.
 - (ii) Status on utilization of funds and eligibility of States for receiving further installment of funds.
 - (iii) Utilization of funds and physical progress in respect of Sub-schemes under RKVY-RAFTAAR.
 - (iv) Reconciliation of Utilization Certificates/Revalidation of funds.
 - (v) Restriction of project duration upto 2019-20 co-terminus of Fourteenth finance Commission.
 - (vi) Component-wise (General, SCSP & TSP) UCs submission from 2017-18 onwards.
 - (vii) RDMIS updating / completion of database, reconciliation of financial progress as per RDMIS with UCs.
 - (viii) Submission of projects related to Waste to wealth.
 - (ix) Status of District Agriculture Plans (DAPs)/ State Agriculture Plan (SAP) and State Agriculture Infrastructure Development Programme (SAIDP).
 - (x) Status of 3rd party evaluation for monitoring of 25% projects.
 - (xi) Progress and issues of Geo- tagging of RKVY assets and moderation, if any.
 - (xii) Discussion on preparation of action plan in advance for 2019-20 (specially SC/ST component). To hold SLPSC/Pre- SLSC/ SLSC for 2019-20 before March, 2019 for timely release of central funds for the next financial year.
 - (xiii) Additional fund sought by State during 2018-19, if any.
 - (xiv) List of PPP-IAD projects in the state.
 - (xv) List of FPOs formed under RKVY.
 - (xvi) Entry of DBT beneficiary data in RKVY-RDMIS portal.
 - (xvii) Maintenance of data-base for pre & post-harvest infrastructure.
 - (xviii) Participation in Agri - entrepreneurship component, etc.

3. The Joint Secretary (RKVY) welcomed representatives of all the concerned States who participated in the meetings. All the Representatives from different States were advised to submit their pending UCs for previous years as well 60% UCs of current year positively by the end of November, 2018 enabling this Division for releasing the 2nd /further instalment of funds. UCs should be submitted separately for General, SC/SP & sub-scheme from 2017-18 onwards. State was informed to submit physical/financial progress reports of implementation of projects. States were informed to restrict the project duration upto 2019-20 co-terminus of fourteenth finance commission; The States were asked about the present position of geo-tagging of RKVY assets along with total number of RKVY assets to be geo-tagged in their respective State and problems faced, if any in this connection.

4. All the participating States were requested to prepare action plan in advance for 2019-20 (especially SC/ST component) upto February-March, 2019. So that the central funds for the next financial year i.e. 2019-20 may be released in time. States were also advised to encourage PPP-IAD projects in the state and FPO's formation. States were also advised about the participation in agri-entrepreneurship development for encouraging innovation and agri-entrepreneurs/ incubation activities in the States, for which states will have to contact their concerned knowledge partner.

5. The state -wise summary of discussions and list of participants are annexed. All States may take action as per the minutes of the meeting.
