Sir.

As you are aware that RKVY - MIS has been designed to provide correct and authenticated data on output, outcome and contribution of RKVY projects in public domain. As per para 10.1 and 12.1 of RKVY guidelines, States are required to enter the details of projects approved by SLSC, alongwith the progress of projects, in RKVY - MIS on regular basis.

RKVY - MIS has accordingly been upgraded for capturing data entry w.c.f. 2015-16 onwards. However, it has been noticed that several States are unable to enter data successfully in the system.

In view of the above, the Department has decided to hold training sessions with States so as to address the difficulties in data entry in RKVY - MIS. The detailed schedule of the training is enclosed.

States/UTs are accordingly requested to send their representative responsible from RDMIS entry to attend the training session as per schedule attached.

Further, it has also come to notice of the Department that the status reports generated with regard to the projects implemented during XIth plan are categorized into various categories i.e. Abandoned, Completed, In progress, Not yet implemented, Substantially Completed. It is felt that there should be only two categories namely Abandoned and Completed, as the projects implemented by the States during XI plan must have been completed by this time.

In view of this, States are requested to go through the "Projects States Count" of XI plan period and make necessary updation in the entries accordingly. Any doubt regarding this, may be brought to the notice of 'Programmer / Assistant Programmer' during the training session in the Department. An Officer well versed with the status of entries may also attend the training session to facilitate updation of RDMIS system.
