**Minutes of the 14<sup>th</sup> State Level Sanctioning Committee (SLSC) meeting of RKVY held on 29.01.2014 in the 3<sup>rd</sup> Floor Conference Hall of Secretariat under the Chairmanship of Chief Secretary, Odisha**

The 14<sup>th</sup> State Level Sanctioning Committee (SLSC) meeting of RKVY was held on 29.01.2014 under the Chairmanship of Chief Secretary, Odisha in the 3<sup>rd</sup> Floor Conference Hall of Secretariat at 12.30 P.M. The list of members & other participants who attended the meeting is placed at **Annexure-I**.

At the outset, Principal Secretary to Govt., Agriculture Department welcomed the Chairman, officials of Government of India and other members present in the meeting and gave the overview of the scheme. He mentioned that Gol have allocated Rs. 53842.00 lakh during 2013-14 of which Rs.48170.00 lakh has been released so far to the State, against which U.Cs of Rs.22548.89 lakh has been submitted to Gol. The gist of 20 project proposals recommended by SLMC held on 05.11.2013 was sent to Gol for their views which have been received for consideration by the SLSC. Thereafter, discussion was held agenda-wise. The details of discussion are as follows:

**(1) Confirmation of minutes of the last meeting of SLSC held on 15.11.2013**

The minutes of the meeting of 13<sup>th</sup> SLSC held on 15.11.2013 were circulated to all the members vide Agriculture Department letter No.20425 dated 03.12.2013. Since no comments have been received, SLSC confirmed the minutes of meeting of 13<sup>th</sup> SLSC.

**(2) Action Taken Report (ATR) on the decisions taken in the 13<sup>th</sup> SLSC meeting.**

The Action Taken Report (ATR) on the minutes of the last SLSC meeting enclosed in **Annexure-II** was discussed in detail. On the request of the Director, DRWA their project "Technological intervention for drudgery reduction with increased work efficiencies through woman friendly farm tools/ equipment/ technology in the State of Odisha" was revalidated with the revised cost of Rs.179.30 lakh sanctioned by 11<sup>th</sup> SLSC.



**(3) Financial progress under RKVY for 2007- 08 to 2011-12**

Principal Secretary, Agriculture stated that during 11<sup>th</sup> Plan Period (2007-08 to 2011-12) Gol have released an amount of Rs.90489.10 lakh, out of which Rs.89910.59 lakh has been utilized and U/Cs have been submitted to Govt. of India.

**(4) Physical status of the projects from 2007-08 to 2013-14**

Principal Secretary, Agriculture informed that 397 nos. of projects have been implemented since inception of RKVY scheme, of which 185 nos. of completed projects have been uploaded in RDMIS. The Chief Secretary & Chairman, SLSC requested the implementing agencies to immediately submit project completion details of the completed projects by March' 2014 failing which funds will not be released to the defaulting agencies for implementation of other ongoing/newly sanctioned projects for implementation of ongoing / newly sanctioned projects.

**(5) Financial Progress:**

**(i) For the year 2011-12**

During 2011-12 the State has received Rs.35696.00 lakh from Gol and released Rs.35917.35 lakh to the implementing agencies. So far, Rs. 35337.30 lakh has been utilized and U/Cs of Rs.35337.30 lakh have been submitted to Gol. An amount of Rs.536.07 lakh has been refunded by the different implementing agencies.

**(ii) For the year 2012-13**

The Gol had released only Rs.46828.00 lakh against the allocation of Rs.50310.00 lakh during 2012-13. An expenditure of Rs.44644.78 lakh was reported by the implementing agencies and U.Cs. for Rs.44353.48 lakh have been sent to Gol.

**(6) Financial position of RKVY for the year 2013-14**

Principal Secretary, Agriculture intimated that Gol have allocated Rs.53842.00 lakh during 2013-14 and Rs.48170.00 lakh have been released by Gol so far. For smooth implementation of the projects, an amount of Rs.51860.49 lakh has been



released to different implementing agencies out of budgetary allocation of Rs.55500.00 lakh of the State. Rs.23086.90 lakh has been utilized and U.Cs of Rs.22548.89 lakh have been sent to Gol. The details of funds released, expenditure made, U/C submitted by various implementing agency are as follows:

**(7) Progress of sub schemes of RKVY for the year 2013-14**

**(a) Bringing Green Revolution to Eastern India (BGREI):**

Gol have allocated Rs.19930.00 lakh for BGREI and released Rs. 19930.00 lakh to the State. So far, Rs.11524.01 lakh has been utilized out of Rs.17300.00 lakh released to the Implementing Agency.



**(b) Initiatives for Nutritional Security through Intensive Millets Promotion (INSIMP):**

Gol have allocated Rs.57.00 lakh under the scheme INSIMP and released the same to the State. The project cost was Rs.137.95 lakh which includes unspent balance of Rs.48.35 lakh & Rs.32.595 lakh of 2011-12 & 2012-13 respectively. So far, Rs.111.95 lakh has been spent.

**(c) Nutri Farm:**

Gol have allocated Rs.1134.00 lakh under the scheme Nutri Farm and released Rs.1134.00 lakh. Rs.155.00 lakh has been utilized so far. The Director, Agriculture informed that by March'2014 another Rs.650.00 lakh can be spent. The physical targets could not be achieved due to non-availability of seeds in crops like paddy, finger millet & sweet potato of specified varieties earmarked in the project by Gol.

**(d) Vegetable Initiative for Urban Cluster (VIUC):**

Gol have allocated Rs.1200.00 lakh under VIUC and released Rs.1200.00 lakh. The expenditure incurred so far is Rs.56.25 lakh. However, Director, Horticulture informed the Committee that by March'2014 100% expenditure would be incurred.

**(e) Special Programme for Oilpalm Area Expansion (OPAE):**

Rs.2514.00 lakh has been allocated by Gol under the scheme OPAE and Rs.2514.00 lakh has been released to the State. The expenditure of Rs.638.31 lakh has been incurred so far.

**(f) National Mission for Protein Supplements (NMPS):**

Gol have allocated Rs.1800.00 lakh for sub-scheme NMPS against the proposals of the State for Rs.2420.07 lakh. Gol have released Rs.900.00 lakh during the last part of December and the same has been released to the implementing agencies, who have assured the Committee to achieve the targets by March 2014.



### **(8) Sanction of new project proposals**

The following projects recommended in 13<sup>th</sup> SLSC by the State Level Monitoring Committee meeting held on 05.11 2013 for sanction, which were deferred to the 14<sup>th</sup> SLSC due to non-receipt of comments of Gol, were placed for sanction in the meeting and decisions taken as follows:

1. *Strengthening of Milk Union Activities for Ganjam District with total project cost of Rs.128.26 lakh submitted by OMFED approved by the Chief Secretary & Chairman, SLSC was ratified by SLSC.*

### **Director, Horticulture**

The Director, Horticulture has submitted 5 proposals, namely :

2. *Establishment of Centre of Excellence in Horticulture with the total project cost of Rs 1089.00 lakh.*  
The project was discussed in detail and it was sanctioned with a condition to finalise the location in consultation with Agriculture Department & OUAT. The location should be easily accessible to the farmers/ entrepreneurs.
3. *Construction of Training Hall for Horticulture Farmers with the total project cost of Rs 8.00 lakh.*  
The capacity of the training hall will be for 50 farmers. The proposal was approved by the SLSC.
4. *Assessment of Soil fertility and preparation of soil fertility maps for various Agro Eco Systems of Odisha with the total project cost of Rs 84.534 lakh.*  
The project was discussed in detail & was sanctioned by the SLSC with condition that there should not be duplication of the projects and the implementation will be under the technical guidance of IISS, Bhopal as per the observation of Gol.
5. *Organic adoption and certification of integrated Horticulture production system with end to end online traceability in Odisha with the total project cost of Rs 2000.00 lakh.*  
The project was discussed in detail & the Committee scaled down the project from 10,000 Ha. to 5,000 Ha. with a project cost of Rs.1000.00 lakh. The



observation of Govt. of India for revision of the cost norms shall also be complied with.

6. *Project proposal for banana Plantation with the total project cost of Rs.420.18 lakh.*

The project was discussed in detail & approved by the SLSC.

#### **Director, Soil Conservation**

The Director, Soil Conservation has submitted one proposal, namely :

7. *Project proposal for taking up activities under RKVY in post cyclone period in Ganjam district with the total project cost of Rs 394.90 lakh.*

The project was discussed in detail & approved by the SLSC.

#### **Water Resources Deptt.**

The W.R. Department has submitted 11 nos. of proposals, namely :

8. *ERM of onfarm development works in Ayacut area of Sukal Distributary and Churali Minor in Satyabadi Block of Puri district with the total project cost of Rs 220.00 lakh,*
9. *ERM works in Ayacut area of Koimetla Distributary, Kangurukonda Minor and sub minor, Potakhal Minor and Sub Minor & Mangipalli Minor and Sub Minor in Kalimela Block of Malkangiri district with the total project cost of Rs 200.00 lakh,*
10. *ERM works of field channels in Talsara command, Sundargarh with the total project cost of Rs 200.00 lakh,*
11. *ERM works of field channels in Hirakud command, Subarnapur district. with the total project cost of Rs 200.00 lakh,*
12. *ERM of field channels in ayacut area of Gop Branch canal in Baliana & Balipatna Block with the total project cost of Rs 120.00 lakh,*
13. *ERM of field channels in ayacut area of Kanas Branch canal with the total project cost of Rs 120.00 lakh,*



14. ERM of field channels in ayacut area of Nimapara Branch canal in Balipatna Block. with the total project cost of Rs 120.00 lakh,
15. ERM of field channels in seven nos of Pani Panchayats of Machhgaon Canal System of Jagatsinghpur district with the total project cost of Rs 106.80 lakh,
16. ERM of field channels in six nos of Pani Panchayats of Distributary No-15,15(A) of Kendrapara Canal, Distributary No-1,3,5 and 8 of Gobari main Canal and Khan Nagar Minor of Karandia Branch Canal with the total project cost of Rs 75.00 lakh.,
17. ERM of field channel works in 10 Pani Panchayats of Ranital Distributary (Salandi Left Command) with the total project cost of Rs 150.00 lakh and
18. ERM of field channel works in 8 Pani Panchayats of HLC Range-III (Baitarani Command) with the total project cost of Rs 175.00 lakh.

All The above projects of Water Resources Department from Sl.No. 8 to 18 were discussed in detail and approved by SLSC with the following comments:

- The cost norms as outlined in the XII plan guidelines of Command Area Development of Water Management (CAD & WM) have to be adhered to.
- As suggested by Principal Secretary, Water Resources Department the projects will be grounded in 2014-15 due to shortage of time during current financial year.
- As suggested by Additional Secretary, GoI, DAC, MoA priority should be given to Blocks having less than 35% irrigation coverage while preparing such project proposals in future.

#### **Animal Husbandry & Vet Sc.**

The Director, AH & VS (O) has submitted 1 project proposal, namely:

19. Organization of Animal Health camp in each cyclone / flood affected G.P. with the total project cost of Rs 268.80 lakh.

The project was discussed in detail & approved by the SLSC with a direction to the implementing agency to complete the project by Feb' 2014.



### **Textile & Handloom Dev. Deptt.**

The Textile & Handloom Department has submitted one proposal, namely:

**20. *Development of Sericulture with the total project cost of Rs.4708.08 lakh.***

The project was discussed in detail & approved by the SLSC with a condition to scale down the project to 50% i.e. Rs.2354.04 lakh & the plantation will be restricted to 1000 Ha. Depending upon the success, further escalation may be possible. The project will commence from 2014-15.

### **Cashew Dev. Corporation**

M.D., Cashew Dev. Corporation has submitted a proposal, namely :

**21. *Replantation of the damaged old and senile plantation and renovation of the nursery infrastructures for production of the quality graft and supply to farmers in cyclone affected areas of Ganjam and other districts with the total project cost of Rs.505.84 lakh.***

The project was discussed in detail & approved by the SLSC with condition to adopt NHM norms & to obtain inputs of the Directorate of Cashew Nut & Cocoa Development (DCCD) during implementation of the project. The project will commence from 2014-15.

The general observations / comments of Gol were discussed and taken for future guidance by all the implementing agencies. They are as follows:

- While implementing the projects, cost norms similar to Gol / State Govt. schemes / programmes will be followed.
- In case, no cost norm is available, SLSC can take a conscious decision on the proposed cost norm based on local parameters.
- The proposals are subject to the condition that there should not be any duplication of funds with the activities of any other scheme.




**(9) Any Other matters**

- i. The project proposals received after 05.11.2013 SLMC which were presented before the Committee are to be placed for discussion in next SLMC, after which the same may be recommended for consideration of sanction in the 15<sup>th</sup> SLSC.
- ii. It was decided to strengthen the RKVY Cell functioning at the Govt. level in Agriculture Department for better appraisal and monitoring. The expenditure will be incurred from the 1% administrative expenditure of total RKVY fund. The following nos. of consultants were approved for engagement in the RKVY Cell :
  - a. Three Consultants as a part of the Appraisal & Monitoring team with one Consultant each from the following qualifications :
    - (i) Graduate in Agriculture with MBA.
    - (ii) Graduate in Veterinary/ Fisheries Science with MBA.
    - (iii) Graduate in Civil Engineering / Agricultural Engineering.
  - b. One Financial Consultant having CA / ICWA qualification.
  - c. One Computer Programmer / System Analyst having B.Tech (Computer Science) or MCA qualification as MIS Consultant.
- iii. The unspent balance Rs.125.45 lakh (2007-08) will be utilized by the Nodal Agency (IMAGE) for preparation of C-DAP/SAP for 12<sup>th</sup> plan period.
- iv. For smooth monitoring and execution of RKVY projects in the District, a District Level Monitoring Committee will be formed under the chairmanship of District Collector with DDA as Member - Convener and all the district heads of the implementing agencies as members.



- v. Release of funds may be made to the implementing agencies upto Gol allocation of Rs.538.42 crore for the year 2013-14. Further, the refund amount available with the Nodal Agency (IMAGE) will also be utilized for implementation of the ongoing projects during 2013-14.
- vi. Director Agriculture has requested to provide Additional fund of Rs.5.00 lakh for the project "Strengthening of State Insecticide Testing Laboratory at Bhubaneswar" due to devaluation of Rupee against US dollar for the imported equipment (GLC, HPLC) for the project. The Committee agreed to provide the differential fund of Rs.5.0 lakh.

The meeting ended with a vote of thanks to the chair and the members present.



















