

**PROCEEDINGS OF THE STATE LEVEL SANCTIONING COMMITTEE (SLSC) MEETING OF RKVY HELD ON 28<sup>TH</sup> SEPTEMBER, 2013 AT 10.00 AM IN THE CONFERENCE HALL OF THE MANIPUR SECRETARIAT UNDER THE CHAIRMANSHIP OF SHRI P.C. LAWMKUNGA, CHIEF SECRETARY, GOVERNMENT OF MANIPUR.**


At the outset of the meeting, the Chairman welcomed Shri Sanjay Bhoosreddy, JS DADF; Shri Sarvesh Rai, Director (Trade & Plant Protection), Department of Agriculture & Cooperation, Ministry of Agriculture, Government of India and all the other participants present in the meeting. He then asked the Additional Secretary (Agri), Government of Manipur to initiate the presentation and place the issues agenda-wise before the SLSC for discussion.

2. The Additional Secretary (Agri), Government of Manipur made a detailed power-point presentation before the committee and placed the following agenda before the SLSC for discussion and decisions.

- Confirmation of minutes of the last SLSC meeting held on 05/10/2012.
- Third Party Monitoring.
- Review of the Financial and Physical Progress of 2012-13.
- Financial Outlay and Physical Programme for the year 2013-14.
- Annual State Extension Work Plan (SEWP) 2013-14 under ATMA.

3. After detailed discussions, the SLSC resolved unanimously to approve the following as detailed below :

- Confirmation of the minutes of the last SLSC meeting held on 05-10-2012 with the approved outlay amounting to **Rs.2400.25 lakhs**.
- Approval for engagement of NABCONS for Third Party Monitoring and to finalised the Terms of Reference for such monitoring by the Commissioner (Agri), Government of Manipur.
- In future, a Screening Committee should be constituted under the Chairmanship of Commissioner (Agri), Government of Manipur for recommendation of allocation of funds under RKVY amongst various line/allied Departments to the State Level Sanctioning Committee (SLSC).
- During the allocation of fund, the SLSC should give priority on those sectors/proposals which would have impact on increasing production and productivity and not on creation of infrastructures unless required justifications for creation of the same is given by the concerned Department to the satisfaction of the SLSC .
- U.C. for the total amount of Rs.1612.00 lakh should be submitted immediately in respect of the on-going projects so that fund under RKVY for the year 2013-2014 might be released by the Government of India at an early date.



- As far as practicable, the cost norms approved by the Government of India should be followed. In case of any deviation, the concerned Department should give required justification for any deviation from the approved cost norms of the Government of India.
- It was decided to allocate 35% of amount allotted by the Government of India under Stream-I under RKVY (excluding sub-schemes), that is, Rs.2299.50 lakhs to the Agriculture Department, Manipur and the balance 65% to various line/allied Departments including EBADA and BRVDB.

4. Accordingly, the following allocation of fund against the belowmentioned list of projects amounting to Rs.2299.50 lakhs had been approved by the State Level Sanctioning Committee (SLSC) as detailed below :

6. Further, the SLSC also endorsed the allocation already made by the Government of India to various line Departments in respect of the following sub-schemes as detailed below :


